Fifty years ago this week: Telephone Line Put in Pokegama Lake. Northwestern Bell Telephone Company is placing about one and one-half miles of telephone cable across Pokegama Lake from the golf course to the Moose Point area, according to Jerry L. Kleven, manager. "The Lake crossing is part of a \$178,000.00 service improvement project designed to provide improved and expanded telephone facilities to the Moose Point and other areas close to Sugar Lake," Kleven said. The 400-pair cable used in the lake crossing was brought to the site in sections this week and pulled into place across the lake ice. Each of the wires had to be individually spliced and the cable joints encased in a water proof plastic seal. Then a trench will be cut thru the 30 inch ice and the cable dropped to the bottom of the lake, 90 to 100 feet deep in some places. "Though Minnesota's hard winters create problems for almost any construction project, in this case, by placing the cable during the winter, Mother Nature is giving us a 30 inch thick ice bridge across the lake. A bridge strong enough to carry the weight of the trucks and other equipment needed," Kleven added. Though the entire route across the lake will be marked with flares and reflectors, Kleven warned the snowmobilers and others on the lake to be alert to the newly cut trench and cable.


