Approximately 1.26 miles of trail construction will be under this contract for the new Len Hardy Trail connecting the Alborn – Pengilly Railroad ATV Trail to the City of Nashwauk. The landownership is US Steel and Mesabi Metallica. The trail utilizes existing corridors developed by UPM Blandin Forestry through Mesabi Metallica land. The trail corridor authorized by Mesabi Metallica is 20 feet wide.

GENERAL SPECIFICATIONS – For the approximately 1.26 miles of new 20-foot-wide trail.
Trail Clearing and Preparation: Clearing, grubbing, and installation of all erosion and sediment control structures.

Full Trail Construction: Finishing, shaping, hardening with pit run and Class 5 aggregate, and installing culverts, and Geo-Web material for trail stabilization. Estimated trail depth is 1’ of material. Tracked hauler equipment will be provided by MNDNR Parks and Trails.
